• ATOS Convention Planning Coordinator completed work on ATOS annual conventions in Indianapolis (2014), and Philadelphia/Wilmington (2015).

• Development of 2016 annual convention in Western Reserve (Cleveland) in process. Los Angles / Orange County 2017 convention in discussion with chapters. ATOS annual conventions in Tampa/Sarasota Florida (Central Florida & Manasota chapters) and Salt Lake City chapter are in development.

• Since 1986 (past 29 years), ATOS has accrued average annual income of \$13,654 in its share of convention profits. Cumulative income to ATOS from those 29 conventions has been **\$395.978**. The ATOS 40% share of profit from 2014 Indianapolis convention was **\$13,566**. Paid attendance was approximately **460**. All conventions were critically-acclaimed artistic successes.
